Scott County Regional Trails Master Plan Project Overview

Plan Scope

Scott County with the assistance of SRF Consulting Inc. is in the beginning stages of developing a regional master plan for two regional trail corridors the Louisville Regional Trail (Big Woods Regional Trail/CH 17 to the planned Merriam Junction Regional Trail connecting to Carver County) and the Southern Scott Regional Trail (from Cedar Lake Farm to Cleary Lake Regional Park). This effort will help implement the Scott County Regional Parks and Trails System Plan identified in the 2040 Comprehensive Plan Update. In addition to addressing the required components for a regional trail master plan as defined by the Metropolitan Council, expected outcomes of the master plan are final alignments for each regional trail search area, cost estimates for construction, maintenance needs, and a prioritized framework to direct the funding and building of the trail corridors. Scott County is the recipient of a Parks and Trails Legacy Grant through the Metropolitan Council which is being used to fund the project.

Stakeholder Involvement

The stakeholder involvement during the planning process will consist of two design teams: Technical Team and a Community Design Team as two planned public open houses. We are asking each township to identify a board member or staff to represent their township as part of the Technical Team. We are also asking each township to help us recruit members of the community to join our Community Design Team. A description of each committee with detailed responsibilities and commitments can be found below:

The Technical Team will consist of Scott County, city, and township representatives, consultants, elected officials, park and natural resource organizations (DNR, Scott WMO, etc.), and other subject matter experts. The Technical Team will meet 6-8 times throughout the planning process jointly with the Community Design Team as well as separately.

- Responsibilities:
 - o Provide input for corridor alignments
 - o Bring technical expertise to the committee
 - o Review feedback from Community Design Team
 - o Assist with open houses

The Community Design Team will actively participate in and provide direction on the creation of master plans for two Regional Trail search corridors in Scott County. This Community Design Team will consist of residents with local and regional interests and will work alongside a Technical Design Team. Members of this team do not need to be regular trail users to apply for the Community Design Team. Interested teens and young adults are encouraged to apply, as it is important to include future users in planning our regional trail system and oftentimes these age groups are not represented on community planning teams. Similar to the Technical Team the Community Design Team will meet 6-8 times throughout the planning process jointly with the Technical Team as well as separately.

2021 – 2022 SCOTT COUNTY REGIONAL TRAILS PLANNING

Community Design Team Members Roles and Expectations

Background:

Scott County is seeking motivated resident-volunteers of all ages, including teens and young adults, to join a Community Design Team that will actively participate in and provide direction on the creation of master plans for two Regional Trail search corridors in Scott County. These corridors include Louisville Regional Trail (from CH 17 to Louisville Swamp Trailhead) and the Southern Scott Regional Trail (from Cedar Lake Farm to Cleary Lake Regional Park). This Community Design Team will consist of residents with local and regional interests and will work alongside a Technical Design Team, which will consist of various County, City, and other technical staff.

The goal of the master planning process is to identify one preferred route, and likely, segments of alternative routes, for each trail corridor. In addition to the technical team and the community design team, the master planning process includes feedback and involvement of the Scott County Parks Advisory Commission, the Scott County Board of Commissioners, and the affected township boards and city councils. Ultimately, the Scott County Board of Commissioners holds final approval authority before submitting the plans for Metropolitan Council approval.

Expectations of Design Team Members:

Applicants must be available and committed to the following:

- ~ 12 month project timeline
- ~6 meetings, primarily in the evening
- In-person and/or virtual activities, meetings, and tours.
- Between meetings, complete homework on your own time.
- Creative thinking on current and future needs.
- Willingness to discuss and make recommendations as a team.
- Willingness to assist at and represent the CDT at Public Open Houses
- Helping to identify trail alignments that meet the recreational needs into the future
- Helping to create master plans that support the vision of the county's regional trail system
